

Agreement

1. Members/Agents shall be defined as companies or organizations privately owned, that are qualified to do business in their local jurisdiction in accordance with the local rules or laws.
2. Your Cargo Network is a Non-exclusive network. Our policy is to have maximum 2 Agents for small countries, 3-4 Agents for middle-sized countries and 1-2 Agents per city in larger countries depending on the activity of our Agent! In special and for good cause we reserve all rights to change the criteria of the membership number mentioned above (e.g: in the Caribbean area an appointed hub Member represents the islands).
3. Your Cargo Network has a special 4-year program as follows:
 - Year 1 (12 consecutive months) – 349 USD + 20 USD Bank fee
 - Year 2 (12 consecutive months) – 399 USD + 20 USD Bank fee
 - Year 3 (12 consecutive months) – 399 USD + 20 USD Bank fee
 - Year 4 (12 consecutive months) - FREE.
- 3/a. In special and for good cause we reserve all rights to change the criteria of duration and the Membership fee amount given.
- 3/b. Your Cargo Network provides the possibility to start Your Cargo Network Membership fee with the first year payment of 349 USD only.
- 3/c. Membership Period is defined as Year 1, which is 12 consecutive months.
4. Conferences are held biannually to allow Members to meet face-to-face for business discussion. In special and for good cause we reserve all rights to change the frequency of holding the Your Conferences.
5. Members must attend the Biannual Conferences. Failure to attend 2 consecutive compulsory Conferences results in revokation of the membership.
6. Annual Conference Date and Place is defined by the Your Cargo Network Director.
7. All Members must respect the nature of confidentiality involved in all agent/client/business relationships.
8. We expect that the Agents must answer to each other's request within 24 hours after their first contact. We expect to answer for the Your Cargo Network Management's emails and mobile application messages within the shortest time possible.
9. It is suggested that all Members should maintain updated all their details such as e-mail address, phone number...etc.

10. Payment between Members is the matter of the Agents, all profits must be agreed between them, and the 30 days payment deadline between them is just a suggestion.

10/a. Members must bear their own bank charges.

10/d. Members must also bear the Your Cargo Network bank charges, which is 20 USD per transfer. This bank fee refers only for the Your Cargo Network Membership fee transfer.

11. Members recognize and understand that all transactions are undertaken at their own risk and discretion and that, under no circumstances, Your Cargo Network can be held responsible.

12. In case of any dispute which does not result of mutual agreement within 60 days, all parties concerned, must report to the Your Cargo Network Director, who investigates and acts on all parties behalf.

12/a. The Agent agrees that any disputes between the Your Members are the matter of the disputing parties, which problem should not be conveyed towards the other Your Members neither throughout emails nor throughout any Your mobile phone applications available. In such matters Your Cargo Network Director provides neutral arbitration between the Your Members and reserves the right to decide if the disputing matter should be discussed among the Members or not.

13. If a Member is deemed to have defaulted on a payment to a fellow member, the Your Cargo Network Director reserves the right to notify all the Members by means of the communication system available.

14. In the event of expulsion, due to non-compliance with the Your Cargo Network Code of Conduct, or stopping of the operation of your company etc., the Membership Fee is not refunded.

15. Resignation or revocation of the Membership during the membership Period does not oblige Your Cargo Network to any refund of the Membership fee. The Membership Period fee and the Bank fee is not transferable under any circumstances.

16. Members may leave Your Cargo Network at any time. The Membership fee is not refunded.

17. In the event of termination or revocation of the membership, for whatever reason, the Member agrees to remove the Your Cargo Network name, logo etc. from its literature, publicity materials, and its login, password as well as the agent's details are terminated with immediate effect.

18. Your Cargo Network shall inform all existing members of the termination or revocation of the Membership status stating the reasons for such occurrence. Nevertheless Your Cargo Network cannot be obliged to provide all and full details of such reasons, which is defined by the Your Cargo Network Director.

19. Hereby we declare and take the responsibility for not giving out the details or any kind of confidential information about the Your Cargo Network registered member companies and agents for any third part's request in no circumstances at all until the registered member of the registered company in the Your Cargo Network agrees in writing to do so.

We may share information with governmental agencies or other companies assisting us in fraud prevention or investigation. We may do so when: (1) permitted or required by law; or, (2) trying to protect against or prevent actual or potential fraud or unauthorized transactions; or, (3) investigating fraud which has already taken place. The information is not provided to these companies for marketing purposes.
